

DANCER'S REGULATIONS

TERMS AND CONDITIONS OF USE
OF THE HALLS: AIRPORT/WHITE/BLACK
at AirDance Space in Warsaw, and
AIR SPACE/PURPLE VIP HALL/BLACK HALL
at AirDance Space in Sopot



General matters:

1. These Regulations set out the terms and conditions for the independent use of the dance halls in the premises of AirDance Space, located in Warsaw 02-258, at 1 Materii Street, by all Dancers and Dancers, Dance Schools, Dance Associations, etc.
2. The condition of using the service of self-entry to the dance halls is: reading the content of these Regulations, accepting all of its points, and signing and delivering it to the office of AirDance Space in Warsaw.
3. Dancer/Dancer agrees to use her/his image for the purpose of Company promotion in case of publication of photos and videos from trainings/workshops/events organized by her/him and special events organized by AirDance Space Warsaw/Sopot.
4. Persons using the halls, are absolutely forbidden to enter the floor of the premises outside the hours of 9:00 - 17:00, when the offices are not working.

Safety and Accountability:

1. For hygiene and safety reasons, it is forbidden to bring food and hot drinks into the hall.
2. The dancer(s) entering the dance hall use the hall and its equipment at their own risk.
3. The Dancer/Dancer bears all financial responsibility for the removal of damages made by him/her or persons for whom he/she is responsible during the conducted classes. Parents or Legal Guardians are financially responsible for minors.
4. AirDance Space is not responsible for injury to the health of a person using the dance hall independently, arising during the independent use of the hall.
5. After leaving the Hall, the Dancer/Dancer makes sure that the entrance door to the building has been properly latched and the entrance gate slid shut.

Lighting and air conditioning:

1. At the end of the class, the Dancer/Dancer leaves the room, turns off the lights and air conditioning after him, and checks that all operating equipment has been properly turned off.
2. Taking care of energy conservation is our shared responsibility.
3. The dancer who is the last to leave the room monitored by the AirDance camera and fails to turn off the lights and air conditioning will be charged a fine of 500 PLN, payable by the end of the current month.

Terms of Use of the Halls and Fees:

1. The service of using the dance halls is available from Monday to Sunday from 7:00 am to 22:00 am.

2. AirDance Space is not responsible for the left things and property of people using the rented hall.
3. In order to use the dance halls on your own, you need to make a cash payment before entering the hall, at the Company's office in Warsaw or at the person representing AirDance Space. The amount depends on the price list, which can be found at: airdancespace.com.
4. Entering the hall without prior notice of your desire to rent the hall, risks a financial penalty of 2x the price of the hall rental.
5. Other room/space rental options and related fees are available in the price list at **www.airdancespace.com**.
6. All room rental fees must be paid no later than the day on which the training/event is to be held, either in cash at the office or by card payment to the terminal - text message with a photo confirming payment to tel: **+48 503 547 668**.
7. Late payment of subscriptions will charge an additional amount of **PLN 10** for each day of delay.
8. In order to maintain harmony between Dancers' training and scheduled events on days such as Friday, Saturday and Sunday, all Dancers are required to complete their training and leave the dance halls according to the schedule. All trainings and classes on these days must be completed at least one hour before the scheduled start of the party/event in the halls. Completion of training means leaving the dance hall, putting away equipment and possibly cleaning the space in a way that will allow a quick and smooth change of the hall for the event.
9. Dancer/Dancer who have a subscription agree to pay it by the 5th of each month for the month in advance, e.g. for the month of November by the 5th of November.
10. The Dancer/Dancer has the right to terminate the applicable subscription with three months' notice. The termination of the subscription should be made in writing and delivered to the email: **biuro@airdanceacademy.pl** in accordance with the provisions of the Regulations and the terms of the Subscription Agreement. During the three-month period, the Dancer/Dancer is still obligated to make payments in accordance with the terms of the subscription, regardless of the actual performance of the classes. In addition, a Dancer who makes a request during the month of May to include a vacation period on a specific date can expect a 50% reduction in the subscription amount.
11. When the number of Dancers in the hall on behalf of one Organization or Coach will be more than 10 people, it will be counted as a group, as it constitutes an exclusive rental of the hall in question on a specific date. This entails payment of the amount from the price list for the exclusive rental of the hall.

Cleanliness and order:

1. The dancer/dancers are required to keep the hall clean. He/she is obliged to make sure that he/she leaves the hall in the condition in which he/she found it after training.
2. If necessary, the Dancer/Dancer is obliged to clean up after himself and his students. Failure to adhere to this rule will incur a penalty at a price depending on the damage and uncleanliness done.
3. In case of the need to cancel the rental of the room, the Dancer/Dancer is obliged to inform the Landlord no later than **48 hours** before the scheduled day of rental at tel: **+48 503 547 668**. This situation may occur up to four times a year.
4. In case of failure to give the required advance notice, the Dancer/Dancer will be required to pay a fee of **50%** of the room rental price.

The regulations are effective from 2023 - until further notice.
